## TERM LIMITS—IMPACTS ON THE NEVADA LEGISLATURE

This fact sheet shows the effect of term limits on the current members of the Nevada State Senate and Assembly. Term limits for State and local officers, including legislators, were approved by Nevada’s voters at the 1994 and 1996 General Elections following a successful initiative petition effort to amend the *Constitution of the State of Nevada*. The term limits state that no person may be elected or appointed as a Senator or a member of the Assembly “who has served in that Office, or at the expiration of his current term if he is so serving will have served, 12 years or more, from any district of this State.” Term limits were first applied to those legislators who were elected in 1998.

### EFFECT OF TERM LIMITS ON NEVADA’S CURRENT STATE SENATORS

In the Senate, the term of two current members will expire on November 3, 2020. Assuming the remaining senators continually run for office in the Senate and are reelected, the terms of seven senators end on November 8, 2022; another six senators are termed out on November 5, 2024; two senators have terms expiring on November 3, 2026; two senators have terms expiring on November 7, 2028; and two senators have terms expiring on November 5, 2030.

<sup>2</sup>Senator Cancela was appointed to fill a vacancy in Senate District No. 10 in December 2016. She is eligible to run for election in 2018 and reelection in 2022 and 2026.

<sup>3</sup>Senator Ratti was appointed to fill a vacancy in Senate District No. 13 in September 2016. She was then elected in November 2016 to fill a two-year unexpired term. Therefore, she is eligible to run for reelection in 2018, 2022, and 2026.

<sup>4</sup>Senator Woodhouse was originally elected to the Senate in 2006, served one term, had a break in service, and was reelected in 2012 and 2016.

## EFFECT OF TERM LIMITS ON NEVADA'S CURRENT MEMBERS OF THE STATE ASSEMBLY

In the Assembly, the term of one current member will expire November 9, 2018. Assuming the remaining Assembly members continually run for office in the Assembly and are reelected, the terms of two members will end on November 3, 2020. In addition, ten members are termed out on November 8, 2022, another eight are termed out on November 5, 2024, and five are termed out on November 3, 2026. Finally, the terms of the remaining sixteen members will end November 7, 2028.

<sup>4</sup>Assemblyman Frierson was originally elected in 2010 and reelected in 2012. He had a break in service and was reelected again in 2016.

<sup>5</sup>Assemblywoman Joiner was appointed to fill a vacancy in Assembly District No. 24 in December 2014 and was elected in 2016. She is eligible to run for reelection in 2018, 2020, 2022, 2024, and 2026.

<sup>6</sup>Assemblyman McArthur was originally elected in 2008 and reelected in 2010. He had a break in service and was reelected again in 2016.

<sup>7</sup>Assemblywoman Spiegel was originally elected in 2008, had a break in service, and was reelected in 2012.

<sup>8</sup>Assemblyman Thompson was appointed to fill a vacancy in Assembly District No. 17 in April 2013 and was first elected to the Assembly in 2014.
